Of the net investment income dividends paid above, 64.93% of the Investment Grade Bond Fund, 84.67% of the Short Duration Bond Fund, 69.56% of the Strategic Bond Fund, 68.26% of the Opportunistic Credit Fund, 37.11% of the Unconstrained Total Return Fund, and 60.67% of the Multifactor Bond Fund are exempt from the U.S. withholding tax.
