## Important information about your investment

As notified previously, Russell Investment Management Ltd became the Responsible Entity of the abovementioned Russell Investments Ventura Funds (each a "Fund" or collectively "the Funds") on 13 July 2022. A new Product Disclosure Statement (PDS) was issued for each Fund (or class of Fund) on that date.

We are now writing to inform you that we have transitioned the custody and administration of the Funds from National Australia Bank Limited to State Street Australia Limited, effective 29 August 2022. State Street Australia Limited is the custodian and administrator of Russell Investments' other managed funds.

Following this transition, the transaction processes for the Funds will align with our standard operating practice. Accordingly, the transaction cut off time on each business day will change from 3pm to 12 noon for the Funds. A 'business day' means a day other than a Saturday, Sunday, public holiday or day on which banks are generally closed for business in Sydney.

These changes are reflected in the new PDS for each Fund (or class of Fund), dated 29 August 2022. Future investments in the Funds are made pursuant to the new PDS.
