- (a) for the product disclosure statement for each Russell Investments ETF (other than for RDV), the product disclosure statement is further updated by deleting the following in the section entitled 'Market maker' with effect from 13 April 2021:

'On 16 March 2021 the market maker appointed by RIM as the market maker of the Fund gave notice to RIM that it would cease to be the market maker of the Russell Investments ETFs on and from 15 April 2021 ("Notice").

RIM is taking steps to arrange to appoint replacement market maker(s) for the Russell Investments ETFs prior to 15 April 2021 and will provide further updates to investors prior to that date'; and

- (b) the product disclosure statement for each Russell Investments ETF (other than for RDV), is further updated by inserting the following in the section entitled 'Market maker', with effect from 13 April 2021:

'We have appointed Nine Mile Financial Pty Limited as market maker in relation to the Funds, effective 13 April 2021. With effect on and from 15 April 2021, neither Deutsche Bank AG, London Branch, or Deutsche Securities Australia Limited (DSAL) will act as market maker in relation to the Funds.'
