We intend to use Russell Investments Material ESG scores, which was developed by Russell Investments in 2018, and draws on metrics developed by industry leaders including Sustainalytics, MSCI and the Sustainability Accounting Standards Board in order to identify and evaluate issues that are financially important to a company. This allows us to distinguish between companies who may score highly on issues that are not financially material to their business.
