## Notice to Investors: Updated fees and costs disclosure

This notice is issued by Russell Investment Management Limited (ABN 53 068 338 974, AFS License 247 185), as the Responsible Entity (RE) of the Russell Investments Australian Shares Fund – Class C (the Fund).

The RE wishes to update the Fund's fees and costs information disclosed in Section 6 of the Fund's Product Disclosure Statement (PDS) dated 11 October 2022. Due to the decrease of the Fund size, we have estimated an increase in the Fund's *expense recoveries* rate disclosed in the PDS, effective from December 2022. The new estimated *expense recoveries* rate has resulted in an overall increase in the estimated *Management fees and costs* and *Cost of Fund*, as detailed in the table below.

As a result of the new estimated *expense recoveries*, we have replaced Section 6 of the Fund's PDS entitled 'Fees and costs' including the *Fees and costs summary* table and *Example of annual fees and costs* table, with a new Section 6 of the Fund's PDS, as set out in the **Appendix** to this notice. This notice should be read together with the Fund's PDS and remains in effect until the current PDS is replaced or another notice is issued whichever occurs first.

As the update to Fund's fees and costs are not considered materially adverse, we have issued this notice in accordance with ASIC Instrument 2016/1055 and made it available on our website at <a href="mailto:russellinvestments.com/au/disclosures">russellinvestments.com/au/disclosures</a>.

### 6. Fees and costs

### **DID YOU KNOW?**

Small differences in both investment performance and fees and costs can have a substantial impact on your long term returns.

For example, total annual fees and costs of 2% of your account balance rather than 1% could reduce your final return by up to 20% over a 30 year period (for example reduce it from \$100 000 to \$80 000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs.
