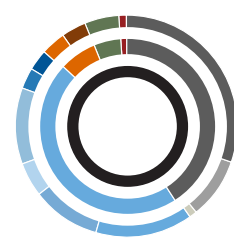
RUSSELL INVESTMENTS DIVERSIFIED MONTHLY INCOME
