Fund Update

Stock selection within the financials space contributed positively to performance; notably an underweight to Heartland Group, which fell more than 15% over the period. Stock selection amongst industrials also added value, including underweights to poor-performing names like Air New Zealand and Fletcher Building. In contrast, stock selection within the healthcare sector detracted from returns; notably an underweight to Fisher & Paykel Healthcare, which jumped almost 11% for the month. Overweights to Ryman Healthcare and Summerset Group also weighed on performance. Returns were further impacted by stock selection amongst consumer staples, including an ex-benchmark holding in Foley Wines. Meanwhile, the Fund's factor positioning strategy outperformed the benchmark in April.

Tobacco Exposure: Defined as the weight of securities in the portfolio classified as being in the GICS tobacco subindustry.
