Low-cost global equity fund targeting lower carbon emissions and improved ESG profile

The Russell Investments Sustainable Global Shares Fund provides investors with a highly diversified, core global equity solution that supports the management of climate change risk and the transition to a low carbon economy. The fund tilts towards firms who score highly on ESG issues that are financially material to their business, while using portfolio constraints to minimise active share and maintain global equity returns.

Available via a tax efficient PIE structure in unhedged and fully NZD hedged versions, the fund offers both developed and emerging market exposure with an expected tracking error of 0.5% against the MSCI All Country World Index (ACWI) index.



The Fund goes beyond carbon reduction alone, aiming to provide an increased exposure to renewable energy, an improved aggregate ESG profile and a targeted reduction in coal exposure. The fund targets firms that are positively exposed to renewable power generation alongside maintaining or improving ESG score.

Monitoring the sustainability agenda

Sustainability will continue to be a key determinant of risk and opportunity for companies globally and will likely evolve over time. Our active sustainability research agenda will ensure that the Fund's strategy will adapt to reflect the changing market conditions, within a risk controlled framework. This means investors in the Fund can continue to benefit from Russell Investments' Innovative sustainability practice over time.

The investment team uses a systematic portfolio construction approach beginning with the MSCI All Country World Index (ACWI). The ACWI is MSCI's flagship global equity benchmark and is a highly diversified index capturing approximately 85% of the global market capitalisation across 23 developed markets and 27 emerging markets. The Fund applies stock, sector, industry and country constraints and minimises active share to effectively deliver low tracking error.

Russell Investments are rated at the highest-level (A+) by the United Nations-supported Principles for Responsible Investment (PRI) as well as being part of Climate Action 100+.
