Fund Objective

To provide a total return, before costs and tax, higher than the Fund's benchmark over the long term by providing exposure to a diversified portfolio of predominantly global listed real estate securities largely hedged into New Zealand dollars.

Fund Update

Stock selection in Japan contributed positively to performance, including our holdings in developers Mitsui Fudosan Co. and Mitsubishi Estate Co. Stock selection in Continental Europe also added value; notably overweights to French mall operator Klépierre S.A., Sweden's Fastighets AB Balder and German residential real estate company Vonovia SE. In terms of strategic factor performance, our preference for quality added further value over the period, while our size bias detracted from overall returns. Momentum, value and volatility factors had no meaningful impact on performance. In contrast, stock selection in the US weighed on returns, including underweights to Realty Income Corp. and Prologis; the world's largest industrial real estate company.

ESG Risk Score: Higher scores imply higher ESG risk.

The ESG Risk Score is the weighted average of the Sustainalytics' Risk Score for companies in the portfolio. The Sustainalytics' Risk Score focuses on ESG issues that are financially material to the company and incorporates both risk exposure and issue management. The scores range from 0 to 100 where higher scores imply higher ESG risk.

Carbon Footprint: Higher score implies greater carbon exposure. The Carbon Footprint is the Weighted Average Carbon Intensity which we define as relative carbon emissions as the weighted average of portfolio companies' Scope 1 & 2 GHG emissions divided by revenue (CO2e/\$1M revenue USD).

Tobacco Exposure: Defined as the weight of securities in the portfolio classified as being in the GICS tobacco subindustry.
