## Fund Objective

To provide a total return, before costs and tax, higher than the Bloomberg Global Aggregate Index – New Zealand dollar Hedged over the long term (3 years plus).

## Fund Update

Credit positioning contributed positively to performance over the period, including overweights to Australian investment-grade financials, US high-yield industrials and European hard currency emerging markets debt. The Fund also benefited from overweights to European investment-grade debt and US non-agency collateralised mortgage obligations. Meantime, interest rates positioning had no material impact on overall performance. The Fund benefited from overweights to shorter-term and 10-year US Treasuries; however, this positioning was offset by underweights to longer-term US Treasuries, German bunds and UK gilts. At the manager level, Coolabah Capital Investors and the Russell Investments Intelligent Credit strategy outperformed their benchmarks, while RBC UK (BlueBay) and Colchester Global Investors both underperformed. Corporate credit specialist Schroders was flat for the month.
