Fund Objective

To provide a total return, before costs and tax, higher than the S&P Global Listed Infrastructure Index NZD Hedged (Net TR) over the long term. The Fund targets a 20% carbon footprint reduction relative to its market index.

Fund Update

Stock selection amongst airport operators contributed positively to performance, including underweights to France's Groupe ADP and Auckland International Airport. Stock selection amongst gas utilities also added value; notably our holdings in China's ENN Energy and Canada's AltaGas. Stock selection within the multi utilities space added further value, including an underweight to California-based Sempra. In contrast, stock selection within the energy sector detracted from overall performance. This included underweights to US natural gas provider The Williams Companies and Canadian pipeline and energy company Enbridge. In terms of strategic factor positioning, our underweight to size had a negative impact on returns, with small caps underperforming their larger counterparts over the period.
