# **Fund Objective**

To provide a total return, before costs and tax, higher than the S&P Global Listed Infrastructure Index NZD Hedged (Net TR) over the long term. The Fund targets a 20% carbon footprint reduction relative to its market index.

### **Fund Update**

Stock selection within the transportation space detracted from performance over the period; notably an underweight to Spanish airport operator Aena SME SA. An overweight to Parisbased Getlink SE also weighed on returns. Getlink SE manages and operates the infrastructure of the Channel Tunnel between France and the UK. Performance was further impacted by an ex-benchmark exposure to telecommunication services. In terms of strategic factor positioning, our underweight to size detracted from returns in July, with small caps underperforming their larger counterparts over the period. In contrast, the Fund benefited from stock selection amongst electric utilities, including an underweight to Spanish renewable energy company Iberdrola S.A. Stock selection amongst multi utilities also added value, including an overweight to US electricity and gas provider Sempra Energy.
