Of the net investment income dividends paid above, 70.35% of the Investment Grade Bond Fund, 75.43% of the Short Duration Bond Fund, 56.47% of the Strategic Bond Fund, 65.69% of the Opportunistic Credit Fund, and 90.46% of the Long Duration Bond Fund are exempt from the U.S. withholding tax.
