Of the net investment income dividends paid above, 81.97% of the Investment Grade Bond Fund, 86.94% of the Short Duration Bond Fund, 64.88% of the Strategic Bond Fund, 70.89% of the Opportunistic Credit Fund, and 100.00% of the Long Duration Bond Fund are exempt from the U.S. withholding tax.
