Fund Objective

The Fund aims to achieve long-term growth on your investment by investing at least 80% of its assets in the equities of companies worldwide, at least two-thirds of which are issued by or in respect of high dividend companies. In addition, the Fund focuses on companies that pay above-average income to their shareholders in the form of a dividend (a share of profits). The Fund is actively managed with reference to the MSCI ACWI (USD) - Net Returns (the Index) which it seeks to outperform by 1.25% over the medium to long term. Russell Investments have full discretion to select investments for the Fund.

Fund Update

The Fund finished in-line with the benchmark return in April. High dividend yielding stocks outperformed other investment styles as equities returned some of their year-to-date returns. The Fund's tilt away from high growth stocks suited this market environment. Positioning and selection within the information technology (underweight) and consumer staples (overweight) sectors contributed positively and included underweights to US large-cap names such as Microsoft and Intel. Selection within financials was also rewarded. However, the overweight to and negative selection within the health care sector weighed on additional returns.
