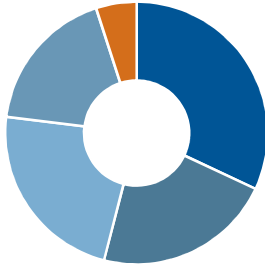

Pool Composition

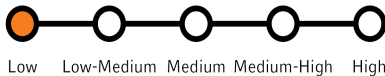

To achieve a high level of current income while protecting capital by investing in, or obtaining exposure to, principally fixed income securities of Canadian issuers.

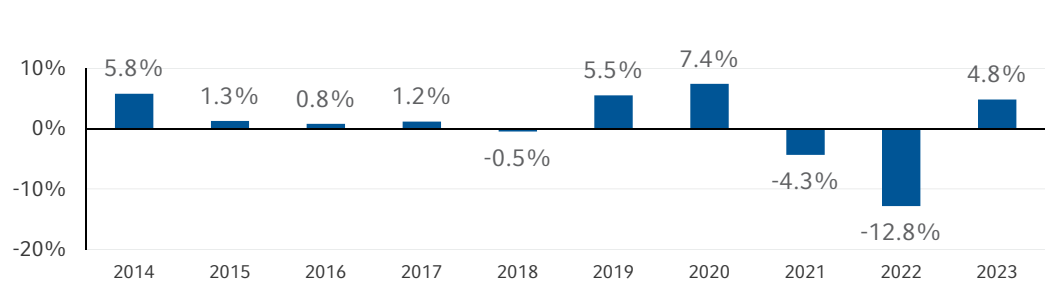
Investment Strategy
