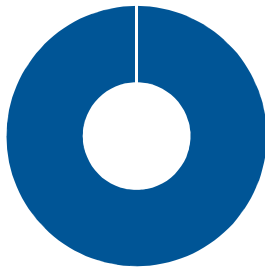

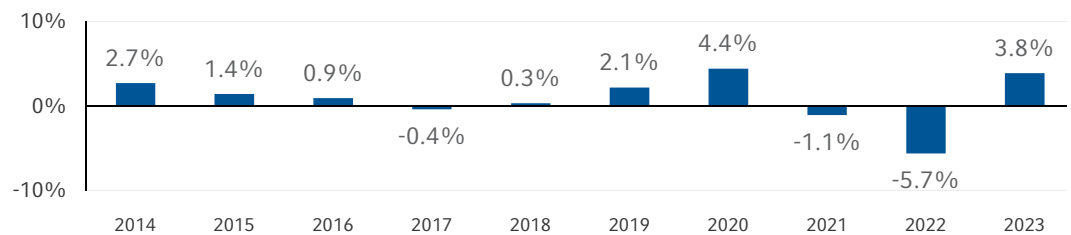
Investment Strategy
