Fund Objective

The Fund aims to achieve long term growth by investing at least 80% of its assets in the equities of companies worldwide. The Fund is broadly diversified across different countries worldwide and industry sectors. The Fund may also invest up to 20% of its assets in emerging markets. The Fund is actively managed with reference to the MSCI World Index (USD) - Net Returns (the Index) which it seeks to outperform by 2% over the medium to long term. Russell Investments/ Money Managers have full discretion to select investments for the Fund. This product is an Article 8 product, as defined under EU regulation - it promotes environmental or social characteristics and invests in companies that follow good governance practices. Fund Update

The Fund underperformed the benchmark return over the month. The Fund's growth tilt was unfavorable in the market environment. In sectors, stock selection within information technology was the main detractor of performance. This included underweight exposure to Apple and an off-benchmark position in TSMC. Overweight exposure to communication services was also punished (overweight Alphabet). However, an underweight to and stock selection within consumer discretionary contributed positively (underweight Tesla, Amazon). Stock selection within industrials (overweight Thales) and financials (overweight ING) was also rewarded. Elsewhere, an overweight to health care was beneficial.
