

# Russell Investments Global Small Cap Equity Fund Article 8

## Fund Objective

The Fund aims to achieve is to achieve capital appreciation by investing in equity securities worldwide, with a focus on investments in small and medium sized companies. The Fund is actively managed with reference to the MSCI World Small Cap Index (USD) - Net Returns (the Index) which it seeks to outperform by 2% over the medium to long term. Russell Investments has full discretion to select investments for the Fund.

## Fund Update

The Fund outperformed the benchmark in the second quarter. In factors, the tilt towards growth and momentum stocks was favourable. In sectors, stock selection within industrials (overweight FTAI Aviation) was rewarded. Other key contributors included overweights to Meiko Electronics within information technology and ADMA Biologics within health care. An underweight to and selection within consumer discretionary was also additive. However, selection within financials (overweight Super Micro Computer) detracted.
