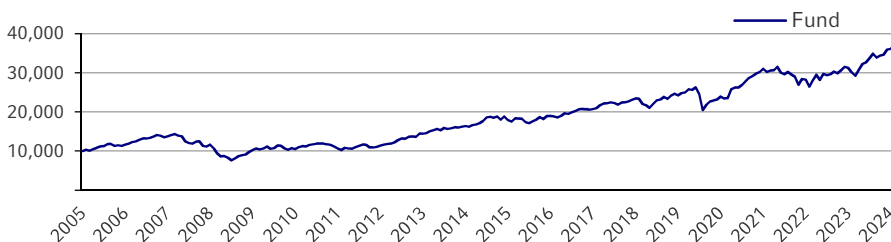

Fund Update

The Russell Investments High Growth Fund outperformed the benchmark in the September quarter.

Within the Fund's global equity portfolio, the Russell Investments Tax Effective Global Shares Fund delivered positive absolute and excess returns over the period; the Fund benefiting from strong stock selection in Japan. This included an overweight to engineering company IHI Corp., which jumped almost 70% for the quarter, and an underweight to car maker Toyota Motor Corp. Stock selection in the US also added value, including underweights to leading chip maker NVIDIA, e-commerce platform Amazon.com and pharmaceutical company Eli Lilly & Co. The Russell Investments Multi-Asset Factor Exposure Fund performed in line with its benchmark over the period; though absolute returns were positive. In terms of domestic equities, the Russell Investments Australian Shares Core Fund generated positive absolute and benchmark-relative returns for the quarter, benefiting from stock selection within the healthcare space. This included underweights to hospital network Ramsay Health Care and biotech company CSL Ltd. Meantime, the Russell Investments Australian Opportunities Fund (RAOF) performed in line with its benchmark. Like the Core Fund, RAOF benefited from stock selection within the healthcare sector; notably an overweight to sleep device maker ResMed. More broadly, our exposures to global listed infrastructure and global and Australian listed property contributed positively to overall performance, while a stronger Australian dollar (relative to the US dollar) weighed on the returns of the Fund's assets denominated in foreign currency.
