To provide current income and long-term capital appreciation by investing principally in equity securities of Canadian issuers on recognized stock exchanges.

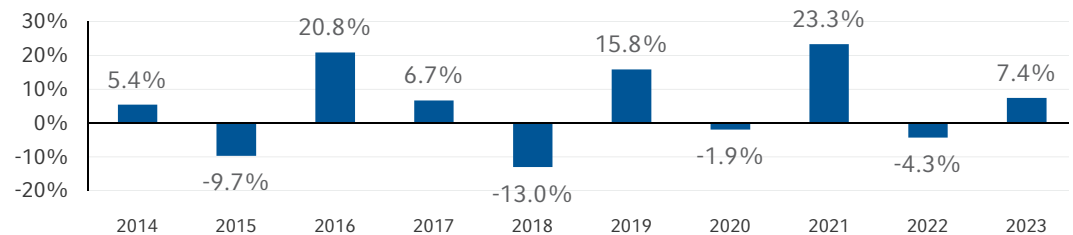
Investment Strategy
