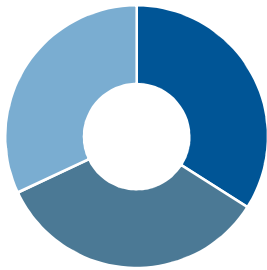

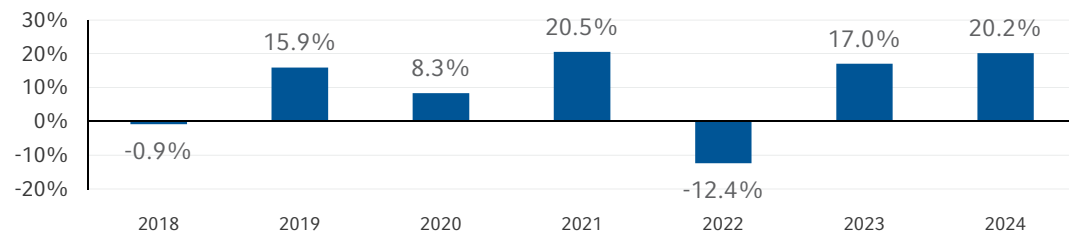
Investment Strategy
