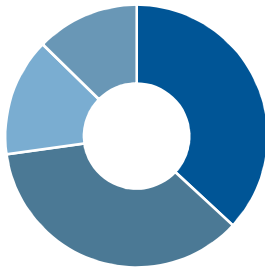

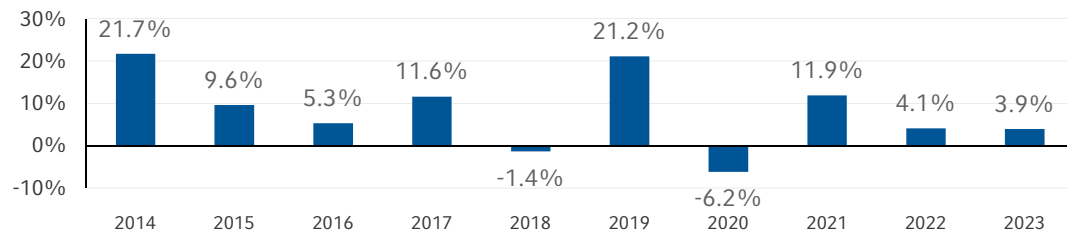
Investment Strategy
