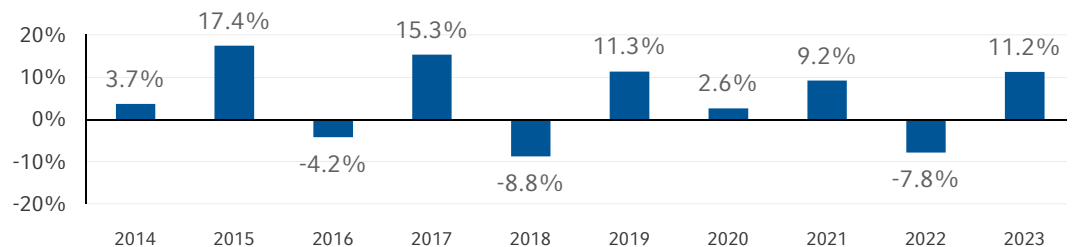
## Investment Strategy
