To provide long-term tax-managed capital appreciation primarily through exposure to a select portfolio of equity securities of global issuers listed on stock exchanges.

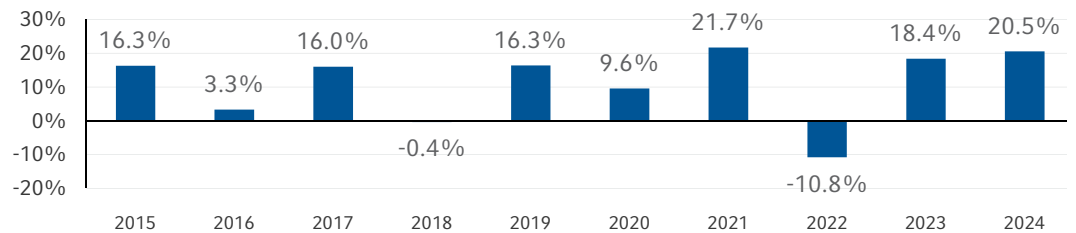
## Investment Strategy
