

Rollover your super using our simple online process.

Just log in at russellinvestments.com.au/login and go to 'Find & combine'. The transfer generally takes three days and you can monitor the progress of your transfer online.

Alternatively complete the three steps on this form and we'll take care of the rest.

- Personal details To get the ball rolling, we've inserted our details (fund name, etc). All you need to do is add in yours.
- Previous fund details This section provides us with all the required information about your previous fund, i.e. where you want to move your balance from. You should be able to find all this information on a statement or letter from your previous fund. You can also get this information by calling your previous fund.
 - It is important you complete this section correctly. Super funds are sensitive when dealing with large amounts of money so if you're not sure of something, give your previous fund a call.
- Declaration and signature The final step is to sign the form and give us consent to disclose your Tax File Number to your previous super fund (FROM fund). Before signing, please compare fees of your super accounts and check for any benefits (like insurance cover) that might cease if you move some or all your super out of your other accounts.

Providing your Tax File Number (TFN)

Under the Superannuation Industry (Supervision) Act 1993, your superannuation fund is authorised to collect, use and disclose your TFN. The Trustee of your superannuation fund may disclose your TFN to another superannuation provider, when your benefits are being transferred, unless you request the Trustee of your superannuation fund in writing that your TFN not be disclosed to any other superannuation provider.

Declining to quote your TFN to the Trustee of your superannuation provider is not an offence. However, giving your TFN to your superannuation fund will have the following advantages (which may not otherwise apply):

- Your superannuation fund will be able to accept all permitted types of contributions to your account(s).
- Other than the tax that may ordinarily apply, you will not pay more tax than you need to—this affects both contributions to your superannuation and benefit payments when you start drawing down your superannuation benefits.
- It will make it much easier to trace different superannuation accounts in your name, so that you receive all your superannuation benefits when you retire.

Your TFN will otherwise remain confidential.
