Change rationale

Based on a recommendation from Russell Investment Management, LLC ("RIM"), the Fund's Board approved the hire of DIFA and the termination of SGA and Coho as money managers for the Fund. This recommendation was driven by several factors, including RIM's portfolio construction considerations and conviction in Macquarie.

The Macquarie Large Cap Growth strategy focuses on stocks of companies with high levels of profitability, return on invested capital, and durable earnings growth. RIM believes that portfolio managers Brad Klapmeyer and Brad Angermeier have displayed a high level of motivation and investment skill with a focus on consistency and continuous improvement to seek to generate positive return outcomes. RIM believes Macquarie's security selection process and Macquarie's focus on highly visible metrics, plus the depth and alignment of their fundamental research effort, differentiate Macquarie from other growth managers.

Change rationale

Bruce Jacobs and Ken Levy founded Jacobs Levy and developed the underlying investment process. RIM believes that Jacobs and Levy are thought leaders within the U.S. quantitative management industry and demonstrate a commitment to high quality quantitative research and model development. RIM believes they are experienced and offer a unique insight regarding quantitative equity investing. RIM also has a positive view of the research professionals who support Jacobs and Levy in model development.

RIM believes Jacobs Levy has demonstrated a valuable combination of thought leadership, rigorous testing, statistical knowledge and economic intuition, and that Jacobs Levy's model is well equipped to adapt to various market environments.
